

Local Brewery Focus. Mutineers

For many years, there were no breweries operating in Bromley, however the situation has changed in recent years. Bromley might not have as many new breweries as some of the inner London boroughs, but we do now have four, with at least one more being planned. Over the next few months, we will be featuring each of these breweries in the e-Newsletter. This month the feature is on Mutineers; our BR5 Area Rep, who is also the CAMRA Brewery Liaison Officer, has been talking to the head brewer.



Mutineers Brewery is a small-scale microbrewery, set up by Rob Vote in 2018. Pre-Covid it was producing about 50 casks per year, all unfined, and so far all sold within a 10-mile radius. All the beers have been named after rebels, rogues, historical events or acts of rebellion.

Head Brewer Rob tells us that brewing started out as a hobby, which has grown and progressively taken over more and more of his life. He has a full time job alongside brewing, although he has now condensed down to four days a week to enable him to brew more regularly.

"My background originally is in engineering; I like knowing how things work, and this led to wanting to know how beer was made. Several years ago, I went to a one day 'all grain brewing experience' at London Fields Brewery. There, I was guided through the mystical art of brewing with milled grain; however the day was also supplemented with a heavy dose of delicious beer, as a result of which I promptly forgot a lot of what I was told.

"Following that hangover, I brought a home brew kit, and invited some friends over to help me work out how to brew beer from home. As with all early home brew attempts, this had a mixture of successes and disasters, sometimes resulting in a flooded kitchen.

"As we got better, and learnt more, we got talking, and wondered if we could get a beer into a cask for sale. After speaking to our local micropub, One Inn The Wood, and filling in the necessary legal documents, we got our first Cask on sale in October 2018.

"Wanting to get more beers out there, this kit was then upgraded to a 100L setup, and housed in a garage in Bromley.

"This allowed for two casks to be produced at a time, or a cask and a lot of bottles. Since the first cask, we have constantly increased our range of ales. The learning curve has been immense, and there is barely a brew session where a new lesson isn't learnt. "The support that we have had from local pubs, clubs and festivals has been fantastic, and there is no way we could have done any of this without their continued support. We have also been able to learn a lot from other local brewers, and it was a great surprise to find so many in the local area when we first started.

"Brewers are always happy to share stories and lessons they have learnt; we are all passionate about the craft, and want to help others improve as well. If you ever have any questions, please do find a brewer."



Unsurprisingly, 2020 was a challenging year for Mutineers, with a lower output than originally planned. However, Rob says that this it has given them an opportunity to create new recipes using the small home brew equipment, and to improve some old recipes with the knowledge gained since the early days.



Locally, Mutineers beers have been on sale at One Inn The Wood, Orpington Liberal Club, Lock & Barrel, Bitter End, Rusty Bucket, and Cockpit. They were also at Bromley CAMRA's Beckenham Beer Festival in 2019. The brewery's Facebook and Twitter accounts announce where the beers are being sold, with more information about the brewery available at www.mutineers.beer

Currently Mutineers are not licenced to sell direct to the public, however they hope to be able to do so in the future.

Walking to the Pub

In 2019 Bromley CAMRA published the first of the **Bromley Pub Walks**, a series of guides to encourage members, and others, to make use of the extensive network of public footpaths in the southern part of our branch area. Guides to five further routes have now been published, with others still in preparation.

There are many miles of public footpaths and bridleways in Bromley, mostly well-signposted and easy-to-follow. These paths can be used to walk between more than **30** pubs and clubs in Bromley, plus a further **7** 'just over the border' in Kent or Surrey.

When walking in the rural parts of Bromley, many people find it hard to believe that they are still in a London Borough. The **Bromley Pub Walks** routes will take you through areas which are working farmland, woodland, wild flower meadows, or pastures where horses graze, plus a few golf courses.

The **Bromley Pub Walks** are mostly routes between pubs/clubs; covering distances ranging between one and six miles. You can choose to do the walks either in bite-sized chunks (should that be pint-sized chunks?), or link several routes together to make a longer walk or 'crawl' to suit your mood and stamina.

The routes could take you past places associated with Charles Darwin, William Wilberforce, William Willett and WW2, and also to what is probably the highest pub in London!

The first 29 routes were published in 2019; it had been hoped to add further routes in 2020, however Covid restrictions delayed the necessary survey and preparation work.

Five new routes have now been added, with a further eight routes due to appear during the summer. Most of the new routes go to pubs in the Kent villages of Halstead and Knockholt Pound, and to Tatsfield and Fickleshole in Surrey.

Further routes are now being planned, which will link the **Bromley Pub Walks** network to pubs, bars and micropubs in Selsdon, Swanley and Sidcup.

Hopefully summer is now about to start, so why not try walking between some of the excellent pubs and clubs on the **Bromley Pub Walks** network?

Are your membership details correct?


Bromley Branch Membership Secretary Norman Warner reminds us all to check that our membership details are up to date.

Pub News

A round up of news about some of the pubs, clubs, bar, breweries, and taprooms in our area.

Bromley Town Centre

Planning Permission has been granted by the Council for the installation of 'Victorian awnings' and signage at 198 High St (next door to the Partridge). Previously this was a pub operating variously as 'Walkabout' and 'Bar Sport'. However, the pub has been shut for several years and the upper parts have now been converted into flats. The application was made by the Livelyhood Group, who run the Faber Fox in Crystal Palace. Bromley CAMRA have contacted the company to enquire when they hope to open for business. We understand that the pub might be operated under the name of **Pamphilon**; the original use of the building was as George Pamphilon, Wine Merchants. Meanwhile, just across the road at the former Royal Bell Hotel, the **Garden Bar** opened on 28th May, we understand that it is offering 'food, juices, cocktails, music'. But no mention is made any of real ale, nevertheless it is good to see part of the Royal Bell reopening for business after being closed for so many years. Beckenham (Kent House)

CAMRA's Brewery Liaison Officer, Dan Clode, has supplied this update about BR3WERY:



The aptly named <u>BR3WERY</u>, is a new Beckenham based brewery and taproom located close to Kent House Station. Opening their new taproom back in December 2020, they adapted to the lockdown situation and supplied draught beer from local suppliers via a great takeaway system. In mid-February the brewkit and fermenters were installed, gearing them up for the production of their own beers.

The current beers brewed on site are their BR3WERY Pils and BR3WERY Ripe, with a sour beer to follow shortly. The former is everything you want from a pils; crisp, light and refreshing.

The Ripe is a Juicy IPA that packs a fruity punch with a wonderful hazy finish. Alongside these, they also serve beers from a number of local South East breweries on draught. With normality (hopefully) now approaching, BR3WERY are establishing themselves as great brewers and supporters of the local brewing scene. An amazing success story and well worth checking out, as they continue to grow!

Beckenham (Clock House)

Meanwhile not very far away, also on Beckenham Road, and sited very close to Clock House Station, the <u>Three Hounds Beer Company</u> has been established since 2017. Initially they were based in a tiny shop, but at the end of 2020 they moved a few doors down the road, to open a 'beer café and bottle shop'. This is on two floors, in a much larger former shop. We understand that they were open for business for only five days, and then had to shut due to the start of the third period of lockdown.





With indoor drinking now permitted, they are aiming to have one cask ale available at all times, with beers sourced from various microbreweries. An excellent 360 Degrees IPA was on handpump when the Editor paid a (slightly longer than planned) visit on 26th May.

Brewer Matt Walden tells us that he currently brews at other South London breweries; By The Horns in SW17 and at Dogs Grandad in Brixton. His future plans include the installation of a 100 litre brewkit on the lower floor early in 2022, which will be used for new trial brews with production brewing to continue at the other breweries.

Chelsfield

The Chelsfield pub, close to Chelsfield Station, is owned by Punch, but for several years it has been operated by Gladewood Taverns. In 2019 Punch sought Planning Permission to demolish and redevelop the pub. A local campaign group Save The Chelsfield was formed and ran a very effective campaign, supported by Bromley CAMRA, which led to the application being rejected.

There is now concern that the pub may once again be under threat, as Punch have given notice to

Gladewood Taverns that they do not intend to renew the current lease which expires on 20th July.

The Save The Chelsfield Group wrote to the Managing Director of Punch Pubs and Co to express their concern. In his reply, Managing Director Andy Spencer wrote that "...the long-term future of the Chelsfield Pub remains our priority and we aim to ensure that the pub remains where it belongs, at the heart of the community for many more years to come". The letter can be read in full on Facebook.

The Save The Chelsfield Group and Bromley CAMRA will continue to monitor the situation.

Chislehurst



Another new venue which also opened during lockdown was the Cockpit micro pub, near Chislehurst War Memorial. We understand that our Membership Secretary, Norman Warner, was 'first in the queue' when they were finally able to open for indoor drinking on 17th May.

The photo shows the bar team posing for an opening day photograph. Unusually, this micropub shares the premises with a florists shop.

Keston

The Fox Inn sadly closed in 2020, when the previous tenants decided not to renew the lease. We are very pleased to be able to report that that it reopened under new management on 17th May, however Bromley CAMRA don't yet have any further information about the new management's plans for the pub. We hope to be able to provide more information in the next issue of the e-Newsletter.



Leaves Green

The <u>Kings Arms</u> has not reopened after lockdown. An application for Listed Building consent has been submitted to the Council for minor refurbishment works, most of which appear to be appropriate for this historic building, with the possible exception of new illuminated external signage. For full information, you can view the application on the Bromley Council <u>website</u> (Ref: 21/00588/LBC)

We do however note that the new signage refers to it being a 'Bar & Turkish Restaurant'. Your Committee has some



concerns that the proposed new use might have a negative impact on the traditional pub atmosphere of this fine old pub, parts of which are believed to date back to 1585. We will continue to monitor the situation.

Mottingham



As anticipated last month as a 'breaking news' item, Lidl have now submitted an appeal against Bromley Council's rejection of their application to demolish and redevelop the <u>Porcupine</u>, in Mottingham.

Bromley CAMRA will be submitting a written comment to the Planning Inspectorate. This is likely to point out that the loss of a community facility, is contrary to Policy HC7 of the <u>London Plan</u> and that there are serious concerns for pedestrian safety, due to the 1.3 metre reduction of the North pavement of Mottingham Road.

Reference may also be made to the flawed 'viability assessment', whereas using CAMRA's <u>Public</u> House Viability Test would give an independent assessment.

Petts Wood

The Council has temporarily closed two parking bays outside the <u>One Inn the Wood</u> micropub, to enable additional seating to be provided.

The pub was able to keep operating throughout most of the last year, in various formats to suit the prevailing Covid restrictions. This including operating as a takeaway and doing home deliveries. As reported last month, earlier this year the pub asked customers to bring in any unwanted laptops and other devices; in all, a total of 125 were donated, refurbished and then given to local primary schools.



It is a sad reality that no pub, club, bar or brewery can ever considered to be 'safe' from closure or radical change.

Bromley CAMRA uses Beer Scores to identify pubs and clubs for possible inclusion in the Good Beer Guide (GBG). Without sufficient scores, from enough members, throughout the year, no pub or club can be considered for the GBG.

This branch has been using Beer Scoring as part of out GBG selection process since the branch relaunched in 2011, and we normally receive several thousand scores each year. All valid scores are taken into account when the 'long-list' is prepared for the annual GBG-Selection meeting (usually held in January).

However, this year, as a result of lockdown and the various Covid restrictions, we have already 'lost' several months of possible beer scoring for 2021. We therefore need to get more scores, from as many members as possible, for the remainder of the year.

It's very easy to submit scores, either using WhatPub, or via the GBG App.

The recommended scoring scale is as follows:

0	No cask ale available	
1	Poor.	Beer is anything from barely drinkable, to drinkable with considerable resentment.
2	Average.	Competently kept, drinkable pint but doesn't inspire in any way, not worth moving to another pub, but you drink the beer without really noticing.
3	Good.	Good beer in good form. You may cancel plans to move to the next pub. You want to stay for another pint and may seek out the beer again
4	Very Good.	Excellent beer in excellent condition. You stay put!
5	Perfect.	Probably the best you are ever likely to find. A seasoned drinker will award this score very rarely.

(Please note that 'half' scores may also be submitted, eg 2.5, 3.5)

Here are a few tips to follow when you are scoring your beers:

- Scores should only be submitted for cask beers (by handpump or gravity) and genuine real cider. Any scores submitted for keg, key-keg or bottled beers/ciders will be have to be deleted.
- Scoring should be based on the condition of the beer/cider, and not on your personal preference about the beer style.
- Please note the national guidance about high scoring, as above. If you do think that a beer warrants a score higher than 4, please add a note to your score to tell us why it was so good.
- Also, if the beer is particularly disappointing, please add a note about that too; we need to know if there are quality problems at any pub or club. All Beer Scores received are regularly monitored throughout the year, so this is an easy way to notify us of any issues with beer quality.

What's Brewing

What's Brewing has gone on line and, whilst there may be grumbles from those who like a paper copy, CAMRA advises that the platform has undergone a significant makeover to provide a new look




and feel, with content tailored to individual visitors, easy to search for articles, plus greater ability to share video, audio and imagery and full mobile optimisation. CAMRA also hopes that the changes will open the platform up to volunteer writers from across CAMRA's 200+ branches and the wider beer blogging community. So, get writing!

One really good move is that the site has been brought behind your membership log-in – so once logged in, you will be able to select news preferences, such as filtering by region or topic interests, and opt-in to a regular news alert sent direct to their inboxes.

Re-opening of pubs

Back on 10th May, with the confirmation that pubs would be re-opening their doors, CAMRA posted delight at the news that customers could once again enjoy the social and wellbeing benefits of being back inside the local, not just the garden. They also noted that the relaxation would help the many pubs, particularly those smaller community 'locals' which do not have an outside space and desperately needed to get their tills ringing again.

The CAMRA National Chair, Nik Antona, added: "The Government should continue to support the beer and pubs sector in the months and years ahead by backing CAMRA's campaign to cut the rate of duty on beer served in pubs – with the savings passed on to publicans and consumers. This would help pubs to compete with cheap supermarket alcohol and encourage responsible drinking in the supervised setting of the community pub."





The Inquiry on pubs and the pandemic

Did you respond to the *All-Party Parliamentary Group on Pubs* inquiry and to have your say on how pubs and communities have been affected by the pandemic.? If you were, you are in good company as 15,000 responses were received in the first week, the closing date was 21st May.

Responses to the Inquiry will be used to produce recommendations to the Government on what action needs to be taken to help pubs thrive post-pandemic.

The Chair, Charlotte Nichols MP, has thanked everyone that took part, observing how the responses are "an incredibly moving testament to just how important pubs are to communities". Adding that, "as more and more pubs are able to reopen, it is increasingly important that they're valued by Government for the key role they can play in our social and community recovery from the pandemic".

Cider update

May was cider month and throughout the month, CAMRA members were celebrating cider 'virtually', with online events and updated content on the <u>National Website</u>,

CAMRA's Learn & Discover platform also hosted content on cider throughout the month, including a video series on the new 'World of Cider'.

But why May, when the apples are cropped in the Autumn? Well, apparently May was chosen because it is when the orchards come into bloom and the fruit begins to set. Let us hope that the weather has not been too detrimental in that respect.

Books

Got a birthday coming up? Or how about father's day? (sorry mums). Beer lovers can immerse themselves in a new title from CAMRA marking how the past two decades have shaped the British beer scene.

'Modern British Beer', written by award-winning writer and photographer Matthew Curtis, maps the evolution of modern British beer through the intricate stories of individual regional beers. This is now available for pre-orders with copies officially available on 12th August 2021.

The new title looks at how the British beer scene has taken its cue from the craft beer revolution in the US and the resurrection of traditional styles in Continental Europe, as well as some home-grown traditions. It goes on to observe that the brewers of Great Britain and

Northern Ireland have carved out a unique and exciting world-leading beer culture.





Bottled Beers

Some good news for the Hogs Back Brewery which has had its 'A over T' crowned the Champion Bottles Beer of Britain in CAMRA's prestigious award, recognising the best bottle conditioned ale in the country. This barley wine was complimented on its rich, complex taste and gentle bitterness balancing the alcohol and making it a delight to drink. 
